FESTIVAL DATES AND TIMES: 17 - 18 May 2025, 0900-2100 Hours

QUALIFICATIONS: Open to both musical and non-musical entertainment acts. 1. Acts must be available to perform at any time during the above hours and must keep both 17 & 18 May 2025 completely clear on their schedule until 11 March 2025. Requests for specific dates and times to perform will not be accepted.

2. A representative from the act must attend both pre-performance meetings scheduled for March 09 and April 13, 2025 (details below).

3. The act does not use telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, (or any subsidiary or affiliate of such entities), or video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities).

4. All members over the age of 15 possess a valid Government issued photo ID.

5. Must be able to transport all members by vehicle to the performance location.

PERFORMANCE TIMES: 20-40 minutes (strictly enforced) per act. Total act duration will be decided by the Yokota Friendship Festival Entertainment Committee (YFFEC)

<u>METHOD OF APPLICATION</u>: Submissions will be accepted beginning in November 2024 and must be received no later than 2359hrs on 13 Jan 2025 JST. Applications will only be accepted electronically. Messages that are sent that do not follow the proper naming protocol will be removed by our automated junk mail filter. Each package must contain the following information/attachments:

- Live Performance Videos
 - Attach links <u>in the body of the e-mail</u> to at least 2 videos posted on a hosting site (i.e.: Youtube*, Dailymotion*, etc.)
 - Must be from a show within the last 2 years.
 - Links to sites without an embedded player or sites that require membership or registration to view the videos will not be accepted.
 - Promotion videos and studio rehearsal clips are not accepted.
- The act's performance schedule for February to May 2025
- Completed application form (last page of this document)
- Ensure you CC your alternate POC as we will respond using "Reply to All" when we send selection/non-selection notifications.

METHOD OF SELECTION: Acts will be judged by the YFFEC based on the submitted videos/packages.
